Our dermatopathology services include:

- Routine light microscopy
- Extensive special stain and immunohistochemical panels
- Immunofluorescence for diagnoses of vesiculobullous and connective tissue diseases
- Molecular diagnostics
- Flow cytometry and gene rearrangement studies for diagnosis of lymphoproliferative lesions
- Robust test menu for blood tests and microbiology

Courier services

Beaumont Laboratory's prompt courier service extends throughout southeastern Michigan. Frozen specimens are transported on dry ice to ensure specimen quality.

Specimens may also be sent by U.S. mail and commercial carriers. Specimens must be packaged according to guidelines set by the carrier. All specimens should be accompanied by a Beaumont Laboratory requisition form, which contains patient demographics, pertinent clinical information, the site of the biopsy and current billing information.

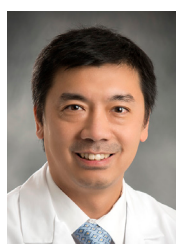

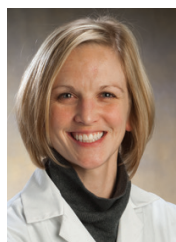

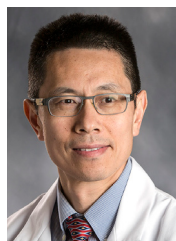
