Reflex Urine Drug Screen Confirmations Discontinuation

Effective Date: December 6, 2022

Beaumont Laboratory will no longer offer reflex drug confirmation testing, effective December 6, 2022.

Drug confirmation testing will be orderable by drug class. Samples for urine drug screens will be retained in the lab for 7 days, during which time confirmation testing can be added. When adding confirmation to an existing specimen, an update/add-on to the original collection must be created. Please also note that confirmation of oxycodone is included in the Opiates confirmation (OPTCF).

Comprehensive Drug Analysis will include standard drug screen and GCMS, which analyzes the sample for presence of thousands of substances.

There will be no changes to the Drugs of abuse panel, without confirmation (DAU). Drugs of abuse with confirmation (DAUP2) and Comprehensive Drug Analysis with confirmation (CMPD2) will be discontinued.
